## **EMERGENCY HOURS OF OPERATION**

Pursuant to the Governor's Declaration of a State Public Health Emergency, as extended, and the ABC Board's authority under the Code of Alabama, 1975 §28-3-2 and §28-3-47, the Alabama ABC Board hereby issues this Emergency Order.

Any ABC licensee found to be in violation of this emergency order shall be subject to immediate suspension of their ABC license pursuant to Code of Alabama 1975 §28-3A-24(b) and §41-22-19(d).
