# TOBACCO USE IN SYSTEM FACILITIES

### HOMEWORK

Parents and students should realize that homework is an integral part of the educational experience as homework provides for practicing important skills. Purposeful homework is a reinforcement of the classroom and will affect the final grade. Students will be assigned homework on a regular basis and should make every effort to complete it on time. Parents are encouraged to ensure the completion of these assignments.

### ARTICLES OF VALUE

Large sums of money or articles of great value should not be brought to school by students. This is for the protection of the owners. The school will NOT be responsible for money or valuable items that are brought to school. Students are reminded that it is not good practice to keep valuables or money in lockers or book bags. Parents should bring any large fees to the office rather than send them by students.

#### LOST AND FOUND

A lost and found box will be maintained in the office. Students may check the lost and found if needed. All sweaters, coats and other personal items should be marked with the student's name and grade. At the end of each grading period, unclaimed items will be given to local agencies for distribution.

## ARTICLES NOT PERMITTED AT SCHOOL

- (A) Firearms, explosives, and other lethal weapons are not permitted at school. Items forbidden shall include but will not be limited to the following: knives, razors or razor blades, box openers, firearms, laser pointers, air/co2 pellet guns, nerf guns, etc., explosive devices including fireworks of any description, chains, items which may be used as clubs made of any materials and of any length, and all sharp or pointed objects for use as weapons. This list is not exhaustive. Students who bring such articles will be subject to Class II or III disciplinary action.
- (B) Students are not to bring radios, I-Pods, Blue Tooth speakers, Frisbees, skateboards, water pistols, cameras or other such articles of entertainment to school. Students who bring such articles will be subjected to Class II disciplinary action. This list is not exhaustive.
- (C) Obscene literature will not be allowed at school either hard copies or digital, etc. Students who bring such objects will be subject to Class II disciplinary action.
- (D) Pepper Spray, mace, or other defensive sprays are not allowed in student possession on campus, at school sponsored events, or in buses. Parents should ensure these sprays are not connected to students' key chains as they are prohibited. (See class III, J.)

### CONFISCATED ITEMS

The school administration will determine when OR if confiscated items shall be returned to the student's parents.

# DRUGS AND ALCOHOLIC BEVERAGES

The use, possession, or sale of any alcoholic beverage, narcotic, illegal drugs, or other controlled substance or the dispersion of same is expressly prohibited in the Daleville City School System. Persons deemed in violation of this policy on campus or at any school related or school sponsored activity shall be adjudged in accordance with the policies of discipline of students. Possession of prescription drugs in school requires approval of the nurse and noted in the student's health care plan.

## SMOKING/TOBACCO PRODUCTS/PARAPHERNALIA

Federal Law prohibits the usage or possession of any tobacco products in school buildings, on school grounds, or during school sponsored activities. Smoking of anything is not allowed, including but not limited to e-cigarettes, vaping devices, or any device meant to aid in the inhalation of any substance. Students violating this policy will be subject to Class II disciplinary action.

Visitors violating this policy will be advised of said policy and compliance is expected.
