



The current Ebola epidemic is the largest in history, affecting multiple countries in West Africa. Three imported cases, including one death, and two locally acquired cases in healthcare workers were reported in the United States.

The Centers for Disease Control and Prevention is taking precautions to prevent additional Ebola cases in the United States by assessing travelers coming from countries with Ebola cases. The Alabama Department of Public Health, Bureau of Communicable Disease, is responsible for monitoring travelers arriving in Alabama and if the traveler becomes symptomatic conducting contact tracing. This training will detail the process for field staff to complete Ebola monitoring and contact tracing.
