In what legal experts are calling the country's first cyber-bullying verdict, a Missouri mother has been convicted of impersonating a teenage boy online in a hoax that led to a young girl's suicide.

Lori Drew was convicted of three misdemeanors for violating MySpace's "terms of service," which requires users to submit "truthful and accurate" registration information. The impact of the case in a Los Angeles federal court is significant, experts say, in that it expands the federal Computer Fraud and Abuse Act, which was passed in 1986 as a tool against hackers, to include social networking Web sites.

The case has drawn worldwide attention and criticism from online experts, including the Center for Democracy and Technology, which accused the government of misusing the law.

The case was tried by the U.S. attorney in Los Angeles, **Thomas P. O'Brien**, after Missouri officials determined that Drew had broken no state laws. MySpace is based in Los Angeles. O'Brien said the verdict yesterday sent an "overwhelming message" to Internet users.

The rental car analogy is a bad example. There are laws covering rental contracts, and have been argued many times in court. By returning the car with less than a full tank you would have violated the terms of the agreement and would have been charged a penalty by the rental agency. If you had however, refused to pay the extra fee you could be prosecuted failure to meet the terms of the agreement you signed. (Which you probably didn't read.) 14-year-old girl faces pornography charge

CLIFTON — A 14-year-old girl faces child pornography charges after she allegedly posted nearly 30 nude pictures of herself on a social networking site, authorities said.

Detectives with the Passaic County Sheriff's Department's Internet Crimes Unit arrested the teen Tuesday. The National Center for Missing and Exploited Children contacted sheriff's detectives about someone posting photos of an underage nude girl on a MySpace profile. The center, which monitors social networking sites for illegal images of children, contacted county detectives through the State Police's Internet Crimes Against Children Task Force, said Bill Maer, the sheriff's department spokesman.

Following a month-long investigation, detectives discovered that the person posting the pictures was the same person featured in them — the 14-year-old girl. Anyone who was "friends" with the girl through MySpace or knew her full name could have accessed the photos.

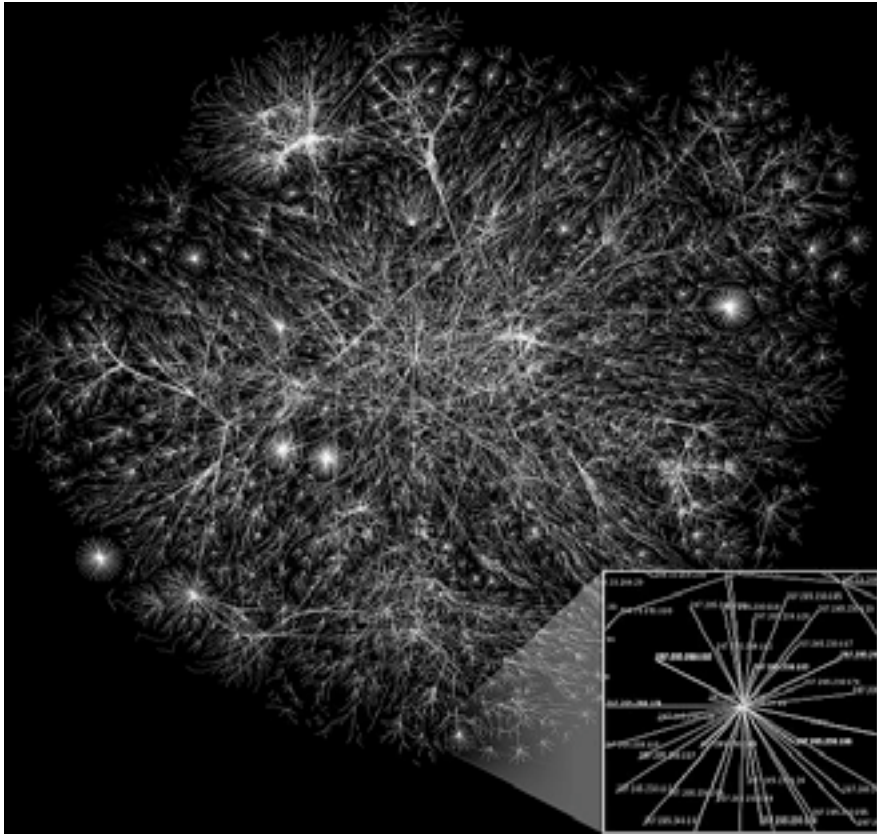
(CBS/AP) One summer night in 2007, a pair of 13-year-old northeastern Pennsylvania girls decided to strip down to their skivvies to beat the heat. As Marissa Miller talked on the phone and Grace Kelly flashed a peace sign, a third girl took a candid shot of the teens in their white bras.

It was harmless, innocent fun, the teens say.

But the picture somehow wound up on classmates' cell phones, and a prosecutor has threatened to charge Miller and Kelly with child pornography or open lewdness unless they participate in a five-week after-school program followed by probation.

On Wednesday, the American Civil Liberties Union asked a federal judge to block Wyoming County District Attorney George Skumanick Jr. from filing charges, saying that the teens didn't consent to having the picture distributed, and that in any event the image is not pornography.

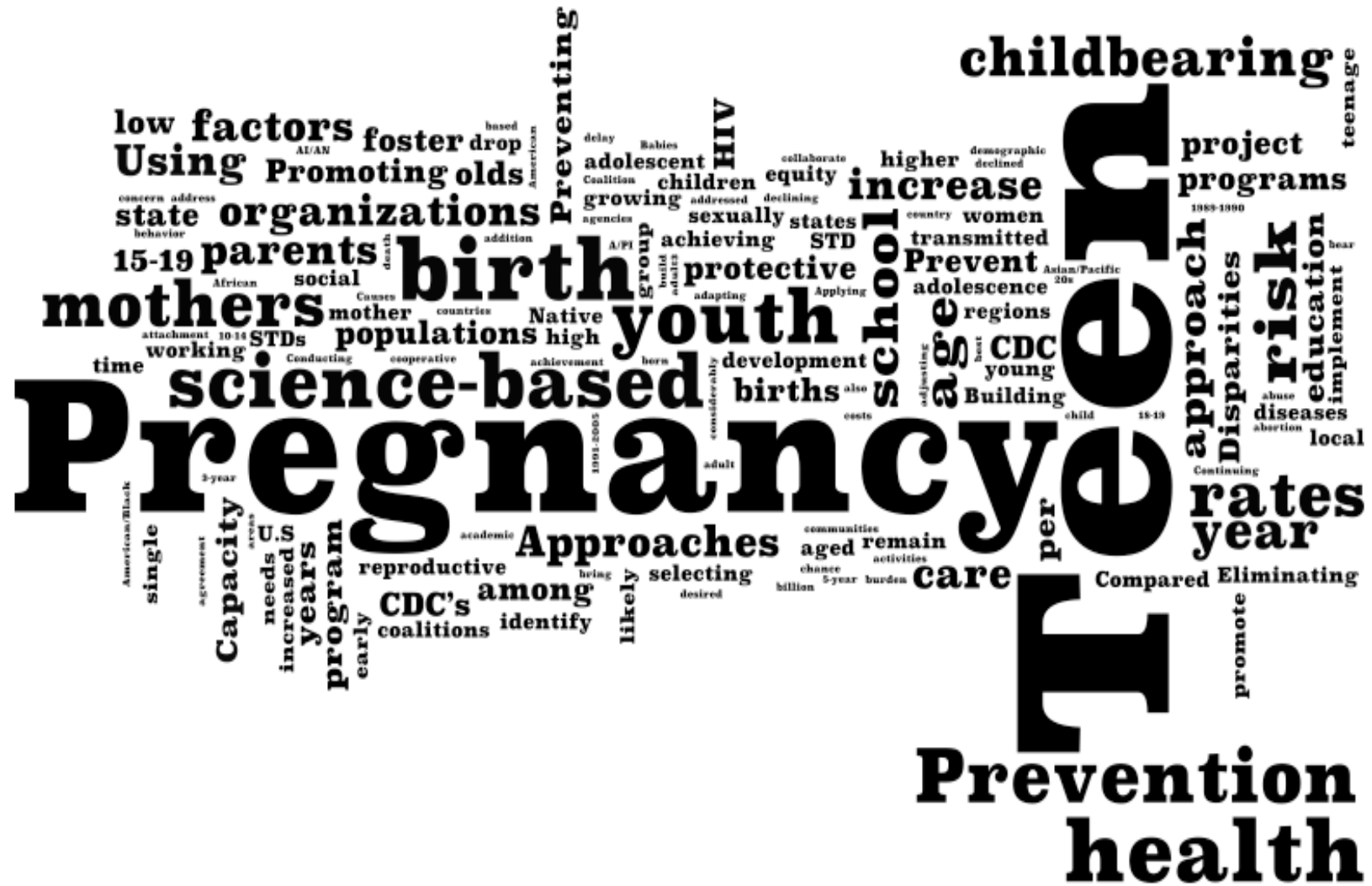

The term "**Web 2.0**" describes the changing trends in the use of World Wide Web technology and web design that aim to enhance creativity, communications, secure information sharing, collaboration and functionality of the web. Web 2.0 concepts have led to the development and evolution of web culture communities and hosted services, such as social-networking sites, video sharing sites, wikis, blogs, and folksonomies. The term became notable after the first O'Reilly Media Web 2.0 conference in 2004.^{[1][2]} Although the term suggests a new version of the World Wide Web, it does not refer to an update to any technical specifications, but rather to changes in the ways software developers and end-users utilize the Web. According to Tim O'Reilly:

“ Web 2.0 is the business revolution in the computer industry caused by the move to the Internet as a platform, and an attempt to understand the rules for success on that new platform.^[3] ”

Tim Berners-Lee, inventor of the World Wide Web, has questioned whether one can use the term in any meaningful way, since many of the technology components of Web 2.0 have existed since the early days of the Web.^{[4][5]}

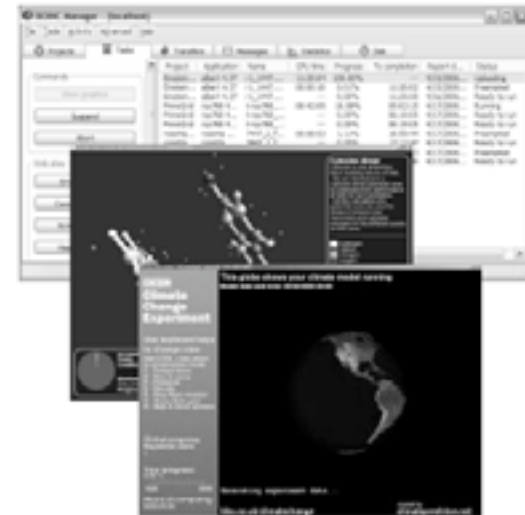

IL-Sen, NY-Sen, PA-Gov: Three GOP Reps Mull Statewide Runs

At a time when the GOP is riven by the debate of whether the party should move closer to the center or further away from it (we have the answer, of course, but we're not telling), three of the leaders in the "moderate" wing of the Republican Party are considering running for statewide office...and potentially abandoning their Democratic-leaning districts.

These three Republicans are:

Mark Kirk of IL-10 (which sported an old PVI of D+3.6)
Peter King of NY-03 (old PVI of D+2.1)
Jim Gerlach of PA-06 (old PVI of D+2.2)

Kirk is considering a run for Illinois' open Senate seat (vacated by Barack Obama), should a special election be held in 2009 (as it may well be, since the Illinois Legislature rightly wishes to strip fallen Gov. Rod Blagojevich of the power to appoint). Were this to happen, Kirk could essentially take a free shot at the Senate race, and wouldn't have to give up his House seat (in an increasingly Democratic district) unless he won. He would have a fairly good chance of winning the Senate election - Kirk is by far the best statewide candidate left in a state party badly depleted of talent, though his votes against pay equity for women, farm subsidies, and his anti-union stances would be potential liabilities in a statewide election.

If Blagojevich is impeached or resigns, and Lieutenant Governor Pat Quinn




