





Referrals

- A Referral should be generated for any abnormal finding, diagnostic mammogram, or abnormal pap smear requiring follow-up
- The Referral and Comments Section currently serves as our Progress Note. This Progress Note will track our entries for follow-up and escalating attempts (i.e. phone call, 1st class letter, certified letter)

Referrals

- To start a Referral
 -Registration in Tree Menu
- Tip Go to Dashboard My Preferences - Patient - Expand Registration Tree Menu
- Allows Referrals to be visible from Note

Referrals

- Incoming Referral Created after being Referred By a provider or specialist
 - Ex: Implant Insertion
- Outgoing Referral- Created when the patient is Referred To another provider or specialist
 - Ex: Abnormal Findings, Pap, or Breast Follow-Up
