Alabama Security Regulatory Proposed Emergency Rule

Administrative Code Rule 832-X-1-17

Rule 832-X-1-17. Licensing and Training Deadline During COVID-19 State of Emergency

Due to the ongoing state of emergency resulting from COVID-19, this Emergency Rule shall be effective until May 6, 2020, unless extended by supplemental emergency proclamation by the Governor or by supplemental emergency rule.

- (1) As described in Alabama Code § 34-27C-7 (a) and (b), a security officer or armed security officer shall apply to the board for initial licensure or certification or renewal of licensure or certification, within thirty (30) days after initial employment or thirty (30) days before licensure or certification expiration, with the appropriate application form as developed by the board, a fee of twenty-five dollars (\$25), and proof of completion of a certified training program or refresher course. The Board is extending the thirty (30) day licensing and training deadline to May 6, 2020. Thus, all applications and proof of completion of a certified training program or refresher course must be submitted and received by the Board no later than May 6, 2020.
- (2) No later than May 6, 2020, all contract security companies shall submit a list of all unarmed and armed security officers in its employ to the Board for verification of licensure and/or application status.
