## RESOLUTION NO. 1083

WHEREAS, THE CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA CONSIDERS THE USE OF SMOKING AND SMOKELESS TOBACCO PRODUCTS TO BE A NUISANCE AND INJURIOUS TO THE HEALTH AND WELFARE OF ITS CITIZENS AND EMPLOYEES; AND

WHEREAS, THE CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA DEEMS IT IN THE BEST INTEREST OF ITS CITIZENS AND EMPLOYEES THAT THEY NOT BE SUBJECTED TO THE HEALTH HAZARDS CREATED BY THE USE OF SMOKING AND SMOKELESS TOBACCO PRODUCTS EXCEPT IN CERTAIN DESIGNATED AREAS; AND

WHEREAS, THE CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA DEEMS THAT THE HEALTH AND WELFARE OF ITS CITIZENS AND EMPLOYEES WILL BE ENHANCED BY PROHIBITING THE USE OF SMOKING AND SMOKELESS TOBACCO PRODUCTS IN BUILDINGS AND VEHICLES OWNED BY THE CITY OF GUNTERSVILLE, ALABAMA EXCEPT AS HEREINAFTER PROVIDED.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA THAT THE CITY COUNCIL DOES HEREBY ESTABLISH A POLICY PROHIBITING THE USE OF SMOKING AND SMOKELESS TOBACCO PRODUCTS IN BUILDINGS OWNED BY THE CITY OF GUNTERSVILLE, ALABAMA WHICH ARE NOT LEASED TO PRIVATE PERSONS OR CORPORATIONS INCLUDING, BUT NOT LIMITED TO, THE CITY HALL BUILDING, THE GUNTERSVILLE PUBLIC LIBRARY, ALL FIRE STATIONS, THE GUNTERSVILLE RECREATION CENTER, EXCEPT IN AREAS THAT ARE DESIGNATED BY THE DEPARTMENT HEAD OR SUPERVISOR IN CHARGE OF THE BUILDING. IN THE EVENT THAT A DEPARTMENT HEAD OR SUPERVISOR DESIGNATES AN AREA AS AVAILABLE FOR THE USE OF SMOKING AND SMOKELESS TOBACCO PRODUCTS THAT IS OFFENSIVE TO CITIZENS OR EMPLOYEES USING SAID PREMISES, THE MAYOR OF THE CITY OF GUNTERSVILLE SHALL HAVE THE RIGHT TO DESIGNATE OTHER AREAS INSIDE OR OUTSIDE THE BUILDING AS THE EXCLUSIVE PLACE IN WHICH SMOKING OR SMOKELESS TOBACCO PRODUCTS MAY BE USED AND CONSUMED.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA THAT THE USE OF SMOKING OR SMOKELESS TOBACCO PRODUCTS SHALL NOT BE PERMITTED IN ANY VEHICLES OWNED BY THE CITY OF GUNTERSVILLE, ALABAMA AND OPERATED BY ITS EMPLOYEES AND OFFICERS WHEN THERE IS PRESENT MORE THAN ONE PERSON IN SAID VEHICLE.

BE IT FURTHER RESOLVED BY THE CITY COUNCIL OF THE CITY OF GUNTERSVILLE, ALABAMA THAT NO SMOKING OR NO USE OF TOBACCO PRODUCTS PERMITTED SIGNS BE POSTED IN PROMINENT PLACES THROUGHOUT THE CITY BUILDINGS AND VEHICLES AFFECTED BY THIS RESOLUTION.

BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE DELIVERED TO THE COMMUNICATIONS MEDIA FOR ITS APPROPRIATE DISSEMINATION TO THE PUBLIC.
