### BANNING TOBACCO VENDING MACHINES IN THE CITY OF TROY, ALABAMA ORDINANCE NO. 155

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TROY AS FOLLOWS:

#### **PURPOSE**

WHEREAS, the United States Surgeon General has long warned smokers that smoking Section 1. tobacco, or any other weed or plant is hazardous to their health; and

WHEREAS, the National Center for Disease Control has concluded that more than 400,000 United States citizens die each year from tobacco-caused or related diseases and tobacco related illness cost businesses and individuals in the United States billions of dollars per year,

WHEREAS, news reports say that over 50 million Americans smoke and at lease twentyand five percent (25%) of Alabama's population smokes; and

WHEREAS, the National Institute on Drug Abuse has found that nicotine in tobacco products is a powerful addictive drug and identifies nicotine addiction as the most widespread example of drug dependence in the United States; and

WHEREAS, it is reported that ninety percent (90%) of adults who now smoke started smoking between the ages of nine and eighteen; and

WHEREAS, three million children smoke daily in the United States, and over seventyfive percent (75%) buy their own cigarettes. Children currently have ready access to cigarettes and other tobacco products as a result of the availability of cigarette vending machines. Scientific studies have shown that minors are successful in buying tobacco products from cigarette vending machines in areas such as bars or cocktail lounges, where minors are not legally permitted to be present, are also readily utilized by minors to obtain tobacco products;

WHEREAS, the United States Surgeon General has consistently favored the elimination and of cigarette vending machines for public health reasons; and

WHEREAS, the American Cancer Society, American Lung Association, American Heart Association, American Medical Association, and Alabama Medical Association, representing the overwhelming view of recognized professional medical associations, support the elimination of credit cards.

The provisions of this ordinance are enforceable by any duly authorized municipal code Section 3. enforcement officer, revenue examiner, policy officer or as otherwise allowed by law.

#### SALE OF CIGARETTES AND OTHER TOBACCO PRODUCTS FROM Section 4. VENDING MACHINES PROHIBITED.

- No person shall locate, install, keep, maintain or use, or permit the location, installation, keeping, maintenance or use on his, her or its premises of any tobacco vending machine used or intended to be used for the purpose of selling or disposing of any tobacco products or tobacco accessories therefrom.
  - Any tobacco vending machine in use on the effective date of this ordinance shall be removed before December 31, 1998 (end of the business license year).

# VIOLATIVE TOBACCO VENDING MACHINES.

Any tobacco vending machine not removed from the premises or converted to a Section 5. permissible use within the time limit set forth by Section 4(b) shall be deemed to be a public nuisance, and may be abated by the City in a civil action or other appropriate legal proceedings.

## VIOLATION; PENALTY.

Any person, firm, or corporation violating any provisions of this Ordinance shall be Section 6. deemed guilty of a misdemeanor and upon conviction thereof, shall be punished as stated below. Each day such violation is committed or permitted to continue shall constitute a separate offense and shall be punishable as such hereunder.

In addition to the fines set out above, for the third and any subsequent violations of this ordinance, the City Council shall conduct a public hearing wherein the violating party shall be examined as to the fitness of the violator continuing to do business within the City of Troy. At the conclusion of said public hearing, the City Council may revoke the business license of the violator to conduct business in the City.

Repeated violations may be the basis for a review of and revocation of presently outstanding business licenses issued by the City.

MISCELLANEOUS.

Construction with Other Laws Nothing in this ordinance excuses noncompliance Section 7. with any state, federal or local law or any rule or regulation which prohibits tobacco vending

unconstitutional, invalid, or unenforceable, such holdings shall not affect the remaining portions

nor render the remaining portions invalid, and to that end the provisions hereof are declared to

be severable.

ORDINANCES REPEALED.

All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are Section 8. hereby repealed.

EFFECTIVE DATE.

This Ordinance shall become effective upon its passage and publication as provided by Section 9.
