## Innovations in Women's Health: A Focus on Technology

### CALL FOR PODIUM ABSTRACTS

The Alabama Office of Women's Health is pleased to announce its call for podium abstracts for the Twelfth Annual Women's Health Update to be held on Friday, August 2, 2019, 8 a.m. until 4:30 p.m. at Grandview Medical Center Auditorium in Birmingham, Alabama. This year's theme is 'Innovations in Women's Health: A Focus on Technology'. Abstracts must be received on or before June 15, 2019. Applicants will be notified of acceptance by June 30, 2019.

The Twelfth Annual Women's Health Update is a continuing education offering for registered nurses, nurse practitioners, pharmacists, social workers, dietitians, and other health care providers. The purpose of the conference is to disseminate scholarly work that is aimed at improving the health status of all women. While the focus of our update is Technology use in Alabama, other topics related to cardiovascular health, diabetes, weight management, nutrition, complementary and alternative medicine, preconception care, mental health issues, community involvement, and health policy are particularly timely.

#### Objectives for the Women's Health Update

- Provide a venue for scholars to share their latest projects and research findings.
- Advance interprofessional collaboration related to health promotion and evidence-based practice.
- Address local, national, and global trends for best practices for women across the life course.

#### Abstract

The abstract should include three learning objectives and be typed using a 12-point Calibri font, single-spaced with double spaces between paragraphs, indentation of the first line of each paragraph, and 1" margins. There is a limit of 500 words. The title should be centered on the first line with name of the investigator(s) and institution(s) centered on the next line. Submit only one page (8 ½ x 11) with the following information as applicable:

- Learning objectives.
- Statement of the topic and or purpose of the project.

- Literature review, clinical practice guidelines, and/or theoretical framework.
- Methodology, sample, setting, procedure, instrument, data analysis (if applicable).
- Findings, results, outcomes, or project impact.
- Recommendations for practice.

### Curriculum Vitae/Resume

A current copy of the applicant's curriculum vitae/resume should accompany the abstract submission and indicate the presenter's educational background, current and past employment history, and other activities related to their experience in presenting the topic chosen.

### Podium Presentation Instructions:

If the abstract is selected for a podium presentation, the Alabama Office of Women's Health will provide specific information related to the presentation, including number of attendees, audiovisual needs, handouts, etc.
