

Prior to this position, she served for more than 30 years in the Division of Primary Care Pediatrics at NCH, having achieved the rank of Professor of Clinical Pediatrics. Dr. Groner's clinical work focused on underserved pediatric populations, and her research interests included multiple aspects of pediatric tobacco and nicotine use, specifically the effects of secondhand smoke on child health, with more than 50 publications related to this topic. Dr. Groner has been keenly involved in advocacy related to all pediatric tobacco issues, including emerging products such as electronic cigarettes. She has conducted numerous presentations by invitation on these topics. She has served as the Chair of the Section on Nicotine and Tobacco Prevention and Treatment for the American Academy of Pediatrics, and is currently finishing up her term on the Executive Committee of that section.
