Vaping, the inhalation of an aerosolized liquid, was first introduced to the United States' market in 2006 and saw a sharp rise in popularity in the 2010s. Among youth, e-cigarettes and vaping devices are the most used forms of tobacco product consumption. Nationwide, laws governing these devices vary widely. E-cigarette and vaping associated lung injury (EVALI) was first described in 2019. It is important that healthcare providers screen their patients for first and secondhand exposure to vaping and e-cigarettes. Expert guidance will be provided on how to help patients who want to quit and in learning about cessation resources available.
