FOREWORD

Sexual harassment in the workplace is a form of sexual violence. Farmworker women in the United States, who struggle to earn decent wages and provide for their families, are particularly defenseless when their employers and supervisors use their power and control to sexually exploit, demean, frighten, and injure them.
