**Trauma System Update**

- The Gulf Region Trauma System was activated on September 14, 2009 with a news conference held at the Magnolia Ballroom in Mobile, Alabama.
- Southwest Alabama Medical Center upgraded from a community hospital to a level three trauma center. Hospital will be surveyed on October 22, 2009
- Providence Hospital in Mobile, AL, trauma system hardware will be installed also on October 22, 2009.
- The East Region Trauma System was activated on October 6, 2009 with a news conference held at the Anniston Star in Anniston, AL.
- Nine out of sixteen hospitals in the Southeast Region has been surveyed. Still no applications from Baptist Medical Center South, Prattville Baptist, Flowers Hospital and Jackson Hospital.
- The West Region RTAC appointees has been presented to the STAC for voting. The time, date and location for the meeting to be announced.
- Statewide activation of the Alabama Trauma System is still set for the end of 2009.

**Revise QI Process/Forms**

Choona gave a brief review of the revised Alabama EMS & Trauma QI Plan Process and other QI Forms that will be used in the Trauma System. All forms will be distributed to the regions. (See attached)

Trauma Plan-The trauma plans for each region will be revised to change the language under the Data Continuing Quality Improvement Component to the original language from the original draft of the trauma plans.

#### QI Report Project Update
