**660-5-41-.05-.01 ER Caseworker Visits and Case Plans**

(1) Preamble. On March 13, 2020, the Governor of the State of Alabama declared the existence of a state public health emergency based on the appearance of the 2019 novel coronavirus also known as COVID-19. On March 18, 2020, the Governor proclaimed the existence of conditions that warrant implementation of extraordinary measures and relief during the state emergency to guard public health and protect human life. Caseworkers are required to have in-person contact for monthly visits, case plans and case plan reviews for adult protective services cases pursuant to Alabama Department of Human Resources' policy Chapter 1 Section A and Chapter 1 Section C.

(2) Due to current health challenges, the Alabama Department of Human Resources found it necessary to modify policy and to temporarily suspend monthly visits for the months of April and May 2020, while still also permitting the option to make contact as needed via videoconferencing and teleconferencing. In addition, the Alabama Department of Human Resources will allow caseworkers to conduct case plans, and case plan reviews with clients via video conferencing or teleconference with adults in need of protective services, who are receiving ongoing services, until the removal of Governor Kay Ivey's Declaration of State of Emergency March 13, 2020, relating to the COVID-19 health emergency or 120 days, whichever is sooner.

(3) If video conferencing or teleconferencing is unavailable, an in-person visit should be completed using social distancing and other preventative measures as needed. The waiver to suspend the in-person requirement should be documented in the family's case record.
