Dear Alabama WIC Participant:

Alabama's WIC Program received notification late Sunday night, February 19, 2023, that Reckitt (Mead Johnson Nutrition) voluntarily recalled a small amount of Enfamil ProSobee Simply Plant-Based Infant Formula due to a possible health risk. The recall includes two batches of approximately 145,000 cans of 12.9 oz powdered formula manufactured between August 2022 and September 2022. These products were distributed through retail stores in the United States, Guam, and Puerto Rico. No illnesses have been reported and no other ProSobee or other Mead Johnson Nutrition products are impacted.

Out of an abundance of caution, Mead Johnson Nutrition is voluntarily recalling formula due to a possibility of cross-contamination with *Cronobacter sakazakii*. All products distributed went through extensive testing and tested negative for the bacteria. Enfamil ProSobee Simply Plant-Based Infant Formula with the following product information is part of the voluntary recall.

- Product: Enfamil ProSobee Powder, 12.9 oz Can
- Global Batch Codes: ZL2HZF and ZL2HZZ
- Universal Product Code (UPC): 300871214415
- Expiration: "Use By Date" of "1 Mar 2024"

A picture of potentially affected products and where the affected codes are printed on the product packaging is included with this letter. Products that do not contain the information listed above are not impacted by the voluntary recall.
